## Submit a claim in three easy steps

To file a claim, simply:

**Download a life claim form at LincolnFinancial.com** and provide answers to all questions, including the Accidental Death Benefit Information section, if applicable.

Gather supporting documents for the claim, including:

- A certified death certificate with the listed cause and manner of death
- Beneficiary address information and payment election
- Supporting beneficiary information if the beneficiary is deceased, an estate, a trust, or a minor
- Copy of the official investigative report, if applicable

## Additional valuable benefits

Your group term life insurance plan comes with other benefits, such as an accidental dismemberment benefit, an accelerated death benefit, and a waiver of premium.

## $\textcircled{$

#### Accidental dismemberment benefit

- Provides a benefit payment in the event you or your insured dependent(s) experiences an injury (depending on severity, for example, the loss of a hand, foot, or eye) resulting in dismemberment
- To access the form, go to LincolnFinancial.com and type "accidental dismemberment benefit" in the search field.

#### Accelerated death benefit (also known as the living benefit)

- Allows you to withdraw a percentage of your coverage early in a one-time, lump-sum amount to help cover treatment costs or other expenses in the event you or a loved one is diagnosed with a terminal illness. Upon the passing of the covered individual, beneficiaries will receive the rest of the money as a death benefit.
- To access the form, go to LincolnFinancial.com and type "accelerated death benefit" in the search field.



#### Waiver of premium benefit

- Enables you to stop making payments on your life insurance coverage if you become disabled and are unable to work for more than six months
- To access the form, go to LincolnFinancial.com and type "waiver of premium benefit" in the search field.
